1. NAME OF CORPORATION:

2. PURPOSE (NRS 81.440(2)):

The specific and primary purposes for which this corporation is formed are to operate exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding section of any future federal tax code, including but not limited to:

- (a) Building and maintaining open-source mesh communication networks to enhance disaster resilience and emergency response in underserved and rural communities throughout Nevada;
- (b) Providing education and training in sustainable computing, digital literacy, hardware reuse, and mesh network deployment to reduce electronic waste and empower local communities;
- (c) Developing, distributing, and supporting open-source hardware and software tools for decentralized, resilient, off-grid internet access;
- (d) Engaging in any lawful act or activity for which corporations may be organized under NRS Chapter 81 that is consistent with Section 501(c)(3).

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on by a corporation exempt under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.

(b) CLASS B – FOUNDING BOARD MEMBERS:

- Members: Leslie Allfree, Edward Mitchell
- Lifetime membership
- One (1) vote each
- Equal rights among Class B
- May not be removed except by Class A

(c) CLASS C – GENERAL MEMBERS:

- Open to all natural persons approved by the Board
- One (1) vote each
- Membership terminable per bylaws
- Equal rights among Class C

GENERAL RULE: Class A has superior governance rights. Class B has lifetime status. Class C shares equally in operational voting and member benefits. All net earnings shall be reinvested in the corporation's charitable mission.
